The Future of Migration Law - Beyond Eurocentrism and new nationalism?

At a time when many supposed certainties are being called into question, there is also an opportunity to break with old ways of thinking and develop new visions for a better future. From the perspective of migration law, this could mean, among other things, becoming more aware of the colonial or Eurocentric roots of migration law and developing new concepts that eliminate global inequalities rather than consolidating them. However, the political trend of a rising nationalism also seems to manifest itself more strongly in the field of migration law. In Europe, this is reflected, for example, in the resurgence of controls at the EU's internal borders. But reform efforts in European migration law have been blocked for years by seemingly insurmountable clashes of national interests.

The annual conference of the Migration Law Network will therefore address the fundamental question of the future of migration law in theory and practice. The analysis will focus on the loss of importance of common European approaches and the effect of increasing tendencies of 'renationalisation'. Moreover, the conference will shed light on postcolonial discourses from academia and social movements and ask about their relevance for migration law practice.

Funding for the conference through the Federal Children's and Youth Plan through the Working Group on Catholic Social Educational Organizations (aksb) has been applied for.
